

tap2go Mobile Application Privacy Policy

1. Introduction

This Personal Information Privacy Policy (hereinafter referred to as the Policy) applies to all information that the tap2go Mobile Application can receive about the user while using the Application.

The use of the tap2go Mobile Application (hereinafter referred to as the tap2go app) means the user's unconditional consent to this Policy and the conditions for processing his personal information specified therein; in case of disagreement with these conditions, the user must refrain from using the Services.

2. Personal information of users received and processed by tap2go app

2.1. For the purposes of this Policy, "user's personal information" means:

2.1.1. Personal information is any information that the user provides about himself, directly including the user's personal data. Mandatory for the provision of the Services (rendering of services) information is marked in a special way. Other information is provided by the user at his discretion.

2.1.2. Data that is automatically transmitted during their use using the software installed on the user's device, including IP address, cookie information, information about the user's browser (or other program that accesses the Services), access time, the address of the requested page.

2.2. This Policy applies only to this Application. The tap2go app does not control and is not responsible for third party websites and mobile applications, to which the user can follow the links available in this tap2go IS, including in search results. On such sites and applications, other personal information may be collected or requested from the user, and other actions may also be performed.

2.3. In general, tap2go app does not verify the accuracy of personal information provided by users and does not exercise control over their legal capacity. However, the application assumes that the user provides reliable and sufficient personal information on the issues offered by the app and keeps this information up to date.

3. Purposes of collecting and processing personal information of users

3.1. tap2go app collects and stores only those personal data that are necessary for the provision and provision of services (execution of agreements and contracts with the user).

3.2. tap2go app may use the user's personal information for the following purposes:

3.2.1. Identification of the party within the framework of agreements and contracts;

3.2.2. Providing the user with personalized services;

3.2.3. Communication with the user, including sending notifications, requests and information regarding the use of the Services, the provision of services, as well as processing requests and applications from the user;

3.2.4. Improvement of quality, convenience of their use, development of services.

4. Conditions for processing the user's personal information and its transfer to third parties

4.1. tap2go app stores personal information of users in accordance with the internal regulations of specific services.

4.2. With respect to the user's personal information, its confidentiality is maintained, except in cases where the user voluntarily provides information about himself for general access to an unlimited number of persons.

4.3. tap2go app has the right to transfer the user's personal information to third parties in the following cases:

4.3.1. The user has expressed his consent to such actions;

4.3.2. The transfer is provided for by European or other applicable law within the framework of the procedure established by law;

4.3.3. To ensure the possibility of protecting the rights and legitimate interests of the app tap2go or third parties in cases where the user violates the User Agreement for the services of the app tap2go.

4.4. When processing personal data of users, tap2go app is guided by the GDPR.

5. Change by the user of personal information

5.1. The user can at any time change (update, supplement) the personal information provided by him or part of it, as well as the parameters of its confidentiality.

6. Measures taken to protect the personal information of users

6.1. tap2go app takes the necessary and sufficient organizational and technical measures to protect the user's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties with it.

7. Changing the Privacy Policy. Applicable law

7.1. tap2go app has the right to make changes to this Privacy Policy. When making changes in the current version, the date of the last update is indicated. The new version of the Policy comes into force from the moment it is posted, unless otherwise provided by the new
